Pursuant to the Agreement between the Employer and SEIU Local 1021, I hereby authorize you to deduct from my wages or salary and to transmit to SEIU 1021 the authorized membership dues, fees, service fee equivalent and/or contributions as certified by the Union. Contributions or gifts to SEIU Local 1021 are not tax deductible as charitable contributions. However, they may be deductible as ordinary and necessary business expenses. Pursuant to state law and the current agreement between the Employer and SEIU Local 1021, all employees represented by SEIU Local 1021, as a condition of initial and continued employment, shall either join the Union or pay a service fee equivalent to fees/dues in lieu of membership. Service fee payers will not receive the rights and benefits of union membership. If such payments are not made by payroll deduction and forwarded to the Union each month, it is the obligation of the employee to make the payment directly to the Union.
