Therefore, direct emergency financial aid grants to students are an institutional priority. Each student who is eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 could apply for this funding. These grants ranged from \$150-\$500. Criteria included but was not limited to employment status, housing costs, technology expenses, and other basic needs. |
| Providing reimbursements for tuition, housing, room and board, or other fee refunds. | \$447,724 | | | The full \$447,724 was used to reimburse students for housing, room, and board. In the interest of health and safety, most students do not live in the dorms and those that do have single-occupancy rooms. This was a cost associated with the disruption of instruction, enabling our campus to stay safe and continue classes. We continue to monitor local, state, and CDC guidelines. |
