Dominican University of California Transfer Agreement

This information has been condensed from the official memorandum of understanding with Dominican University of California.

Undergraduate Admissions

- Any undergraduate Holy Names University (HNU) student in good standing (2.0 GPA or higher) will be
 admitted to Dominican University of California (DUC). Students interested in a specialized program such
 as Nursing or Applied Computer Science may need to meet additional requirements.
- DUC will waive the application fees for HNU students.
- HNU students do not need to complete DUC's full application. HNU students can complete DUC's "Fast App" using this link https://www.dominican.edu/welcome-holy-names-university-hnu

Undergraduate Articulation (Course-by-course evaluation for transfer)

- DUC will waive residency requirements_for any HNU student transferring to DUC in the 2022-2023 and 2023-2024 academic years. This policy is designed to ensure the on-time graduation of upper-classmen. This policy does not affect specialized programs such as Nursing. Please reach out to your DUC enrollment counselor for further details.
- DUC's core requirements will be met through HNU's General Education Requirements which are outlined in the full articulation agreement.
- DUC will accept P and D grades at HNU to fulfill core and major requirements, but students will still need a 2.0 overall GPA to graduate.
- DUC will accept all transfer credits from regionally accredited colleges or universities. This only applies to students transferring into DUC in the 2022-2023 and 2023-2024 academic years.
- Unofficial transcripts can be used from HNU for admission purposes and program evaluations; however, official transcripts will need to be submitted after students have completed the admissions process.

Graduate Admissions

- Any graduate student at HNU in good standing (program dependent) may apply for graduate admissions at DUC. Admissions is not guaranteed but generous consideration is given to HNU students. No application fee is required.
- DUC will evaluate all graduate-level courses taken at HNU on a course-by-course basis. All courses are not guaranteed to transfer but every effort will be made to ensure transferability of courses.
- DUC does not guarantee a completion date for HNU graduate students.
- These policies will only affect HNU graduate students entering the 2023-2024 academic year.
- Updated information regarding transferability of programs and courses will come from your graduate program coordinator.

Graduate Articulation (Course- by-course evaluation for transfer)

HNU students applying for study in graduate or professional programs will need to work with the
admission officer for the specific graduate or professional program in order to
determine which HNU classes may transfer. This will vary from program to program due to specialized
accreditation and degree requirements. See <u>full articulation agreement</u> for more detailed
information regarding some graduate programs.

Financial Aid

- HNU students transferring to DUC will be considered for any applicable institutional aid and all federal aid programs. Students wishing to apply for federal financial aid must update their FAFSA with DUC's institutional code [001196] by March 2nd, 2023. (However, students can complete the FAFSA up to July 15th, 2023)
- HNU students transferring to DUC under this agreement will automatically be considered for an HNU-transfer scholarship.
- California Dream Act Application must be submitted by March 2nd, 2023.
- Students who wish to renew their financial aid award must meet all requirements outlined in DUC's
 Financial Satisfactory Academic Progress (SAP) policy which can be found at
